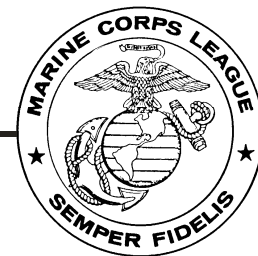

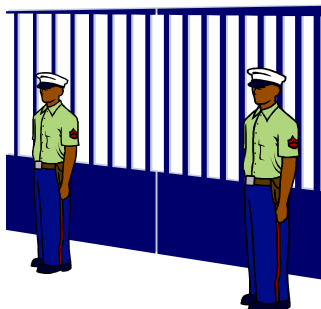
Sadly the price of war has come home to one of our Pennsylvania Marines. Derrick Sharpe sustained horrendous damage as a result of action in Iraq. He has lost his leg, his buttocks, part of his skull, and rectum. He must forever be attached to a colostomy bag. Only three other GIs have suffered the degree of his wounds and lived. During past wars he would not have lived. He has need for money to pay for his transportation to his doctors and hospitals and help with simple living needs. He requires physical assistance in walking, and his military pay doesn't pay for incidentals. He was a Lance Corporal when he sustained his wounds. As he is still on active duty, he was recently promoted to Cpl. He is only twenty years old.

A motion was presented and passed at our general meeting that we provide Cpl. Sharpe with a \$1,000.00 donation to help cover some of his expenses. Donations from some of our Detachment members and other friends of the Detachment matched and in fact exceeded our Detachment donation.

At our general meeting March 3, 2008, we will have as our guest, Bill Walsh, Congressman Sestock's District Manager. He will speak about the Veterans services available through the Congressman's office.

The primary purpose of this month's report is to outline plans for our 2008 fund raising campaigns. Members who were active in last year's fund raising campaigns were consulted for ideas. We also drew on what we learned during last year's campaigns. We will:

- renew last year's TV Bonanza Campaign which will run from March 1st through June 2nd. Its title will be "**TV Bonanza II**";
- attempt to expand the number of Members seeking donations from both individual and corporate donors;
- renew our Birthday Ball Program Ad Campaign to run from August 1st through early November;
- significantly change our approach to what has been known as our JTH "Wagon Sales" campaign. The new campaign will be called "**Drawing for Dollars**"

We ask that all Members take TV Bonanza II tickets on consignment with a commitment to try to sell as many tickets as possible. **There will be no commitment for the Member to buy the tickets!** Tickets will be available for Members at our March Meeting. For those Members who will not be at the Meeting and wish to take tickets on consignment, please call me at 610-356-8893. I will arrange prompt delivery of your tickets!

Our "**Drawing for Dollars!**" Campaign will:

- involve drawing for cash prizes of \$1000, \$500, \$250, \$150 and \$100 instead of using a wagon as the object of the Drawing;
- use the same number of sales days as we have scheduled in the past with as many double location events as is practical;
- schedule the sales dates to match the higher traffic seasons of our store locations. We will drop the summer months and schedule Saturdays on April 5th through May 31st and August 30th through November 29;
- continue to solicit donations or ticket sales from shoppers to support our wounded troops, hospitalized veterans and needy families;
- update our posters and other communication pieces to more graphically display what we do and who we help;
- change ticket prices to lessen our paper work while keeping prices affordable. Prices will be \$2.00 for one ticket, \$5.00 for three tickets and \$10.00 for six tickets;

A preliminary schedule of "Drawing for Dollars!" calendar dates and locations will be provided at our March 3rd Meeting.

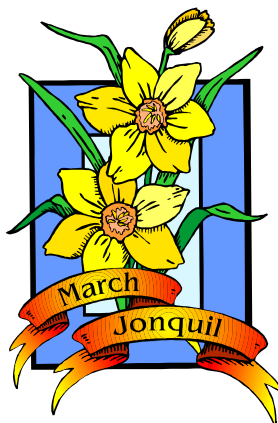

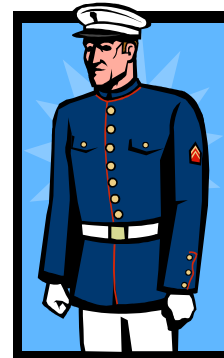

General Meeting Minutes
4 February 2008

Commandant: Commandant Earle Drake opened the meeting at 1930, and the normal opening ceremonies were conducted. Officers present were Commandant Earle Drake, Sr. Vice Jim Robinson, Jr. Vice Jack McLeod, Judge Advocate Dan Luty, Adjutant Jack Kelly, Paymaster Bob Spano, Chaplain Chris Bush, Sergeant-at-Arms Jim Ross, Director Paul Ferguson, and Director Bernie McGinley.

Minutes: Minutes of the January 2008 meeting were reviewed. Joe Conigliaro made a motion to accept the minutes as published in the *Scuttlebutt*. Spence Goldsborough seconded the motion, and the motion passed.

New Member: Paul Vergalla was introduced as a potential new regular member. He was sponsored by Jim Ross, who gave some brief details of Paul Vergalla's USMC service. After his introduction, he was accepted into membership, and he was sworn in by Commandant Drake.

Officer Reports:

Commandant: Commandant Drake reported that he had attended the Marine West Expo at Camp Pendleton in California in January. He had also attended a Department meeting and a Southeast District meeting during January. He also outlined several dates for upcoming events at the Department and National levels. He reported on Marine Cpl. Derrick Sharpe who had received extensive injuries while serving in Iraq. A motion was made by George Boyajian that the Detachment donate \$1,000.00 to Cpl. Sharpe to cover some of his expenses. Spence Goldsborough seconded the motion, and the motion passed.

Sr. Vice: Jim Robinson reported that he had joined the Honor Guard for military funerals, and encouraged others to become involved in this endeavor. Wayne Barner is the contact person for the Honor Guard. Jim Robinson mentioned that the Paxon Hollow Country Club is being considered for the Detachment's Marine Corps Birthday Ball. Additional information will be provided as it becomes available. Jim Robinson also reported on two possible trips, one to the USMC Museum in Virginia, and another to the Marine Expo at Camp Lejeune in September.

Jr. Vice: Jack McLeod reported that there will be another TV Bonanza Campaign again this year, running from 1 March to 2 June 2008. The Birthday Ball ad campaign will run from 1 August through early November 2008. The Detachment will significantly change its approach to what had been the wagon

sales campaign. Instead of the Junior Troop Handler wagon, we will award cash prizes for the drawing. We will also rely more on direct donations. Sales activities will be conducted in April and May, then close for June, July and most of August, and begin again in late August and last through November.

Adjutant: Jack Kelly referred to a letter from the Department of Veterans Affairs in Philadelphia, acknowledging a donation made by the Detachment. He also read a memo of thanks from Judy Burns, widow of former member Ed Burns, thanking the Detachment and the Honor Guard for the services provided at Ed's funeral.

Paymaster: Bob Spano reviewed the Paymaster's report for January 2008. Bernie McGinley made a motion to accept the Paymaster's report as received. Joe Conigliaro seconded the motion, and the motion passed. Bob Spano then presented the proposed budget for 2008, and he addressed questions or made clarifications as needed. Bernie McGinley made a motion to accept the budget as presented. Chris Bush seconded the motion, and the motion passed. Bob Spano mentioned that Cpl. Derrick Sharpe, who the Detachment will be sending a donation to, lives in Berwick, PA. Cpl. Sharpe had attended the MCL Department Meeting in January, and that is how Earle Drake and Bob Spano became aware of his situation. The donation from our Detachment will be sent to the Anthracite MCL Detachment in West Hazelton, PA, since that Detachment is assisting with Cpl. Derrick's financial affairs. In other matters, Bob Spano made a motion to donate \$1,000.00 to the USO in Philadelphia. Ben Sides seconded the motion, and the motion passed. Bob Spano made a motion to donate \$1,000.00 to the Salvation Army. Spence Goldsborough seconded the motion, and the motion passed. Harry Kaufman made a suggestion to consider donating to the Navy and Marine Corps Relief Fund. This suggestion will be considered at the next staff meeting.

Judge Advocate: Dan Luty read a recommended proposal from Paul Ferguson, regarding a process for the dispersal of funds for various charities. In short, any request would be forwarded to the Board of Trustees, and the Board would review, investigate, and recommend to the membership whether or not the Board is in agreement with the request. The membership would have the final approval on the request. If this proposal is adapted, it would become Administrative Procedure #A15. John Williams made a motion to accept the proposal as read. Joe Conigliaro seconded the motion, and the motion passed.

Chaplain: Chris Bush mentioned that Stan Short and Steve Neri were both in the hospital, and that Dave Brimble was not feeling well, but he was at home. Bill

Director Paul Ferguson/Locker Box: Paul Ferguson mentioned that the semi-annual audit of the items in the locker box had been completed prior to this meeting. Some older items will be available after the meeting for a donation or purchase, and some older remaining items will given to Jack McLeod for possible distribution at the sales locations.

Committee Reports:

V.A.V.S./Americanism: Bob Matthews reported that the next bingo party at Coatesville is scheduled for 11 February 2008. In addition, a Valentine's Day party is scheduled at Coatesville for 13 February 2008.

Flag Collection: Barry Reese mentioned that the flag collection efforts are on-going.

Historian: Bob Cosgrove requested that if members see items in the local press involving Detachment activities to forward those items to him, as he does not live in the immediate area. He may not have a chance to include the items in the history book, unless forwarded to him.

Ceremonies: Wayne Barner reported that the Honor Guard served at 19 funerals in January 2008. Two have already been completed in February, and four others have already been scheduled.

Marksmanship: John Williams reported that the MCL Department of Pennsylvania rifle match is scheduled for 26, 27, 28 September 2008. The pistol match is scheduled for 6, 7, 8 June 2008. He also reviewed the specific firearms requirements for each match.

Newtown Township Vets Park: Stan Short was not in attendance, but Bob Spano provided a brief report from Stan Short. Stan has been looking for a home for the Detachment, possibly from a benefactor or some other source. Before any decision would be made, he would bring all available information before the membership for whatever action would be taken.

Property: Bob Spano reported that all of the Detachment's property that was in Dave Brimble's garage has been removed, and it is now located in Bob Spano's business warehouse.

Scholarships: Wayne Williams indicated that he now has the information packets available for those who may want to apply for academic scholarships for family members. He indicated that there are four types of scholarships available. The scholarships available are the Detachment scholarships, from the MCL Department of Pennsylvania, from the Marine Corps National Scholarship program, and from the Marine

Corps Foundation Scholarship program.

Unfinished Business: Bob Spano distributed several awards to individuals who had not been at the meeting in January. He also distributed some certificates for the Toys for Tots program.

New Business: Dan Luty provided some information on this year's March of Dimes program. The March of Dimes walk this year will be on a Saturday instead of Sunday, and those interested can either participate by walking or by making individual donations. The walk is scheduled for 26 April 2008, in Ridley Creek State Park.

Good of the League: Bob Spano indicated that individuals who may want to donate funds for the newsletter could contact him.

George Boyajian made a motion to adjourn the meeting. Ben Sides seconded the motion. After the normal closing ceremonies, the meeting was adjourned at 2045.

Joe Hudson won the 50/50. Forty-two members signed the logbook.
