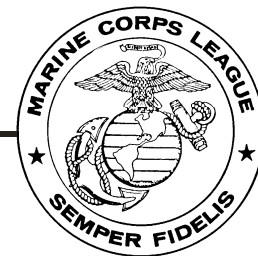

## Commandant's Report September 2009

Just a little reminder that September's meeting is on Wednesday, September the ninth instead of the usual First Monday. This is because of the Labor Day Holiday that falls on our usual first Monday.

We have again lost one of World War II members. **C. Spencer Goldsborough** has gone home to meet the Lord. Spence was one of the seven League members that took the Eagles tour at Lincoln Financial Field and the Nova Care Center. He had a very good time and appeared to be in top physical condition. He was a regular at the Honor Guards and spent many Saturdays raising money for our community and veterans. We will miss Spence.

The Detachment and the Marple Newtown Combined Veterans Alliance took part in services that included the Brief Order for Deceased Marines.

On October 23, 1983 our Marine barracks in Beirut, Lebanon was viciously attacked by a suicide bomber. At 6:20 a.m. a yellow Mercedes Benz truck crashed through a barbed wire fence around the parking lot, passed between two sentry posts, crashed through a gate and drove into the lobby of the Marine Headquarters. The Marine sentries at the gate were operating under rules of engagement which made it very difficult to respond quickly to the truck. By the time the two sentries had locked, loaded, and shouldered their weapons, the truck was already inside the building's lobby. The murderous driver detonated his explosives, which were the equivalent of 12,000 pounds of TNT. The explosive force of this cowardly attack caused the four story building to collapse, killing 220 Marines, 18 Navy personnel and 3 Army soldiers. Sixty Americans were injured. It was the deadliest single-day death toll for our Marine Corps since the battle for Iwo Jima.

Our Detachment will have our Color Guard and Ceremonial Buglers present for the ceremonies which will take place at 1000 on Sunday, October 25<sup>th</sup>, at Foglietta Plaza, Columbus Blvd. and Dock Street. This is the site of the Vietnam and Korean War monuments. Detachments of the Marine Corps League from far and wide will be present for the ceremonies. We will car pool from Eldorado Carpets. You are invited to come and participate or to observe.

The 100 yard combined Marine Corps League Rifle match was held August 2, 2009. The shooting took place under monsoon conditions. Neither the shooters nor the spotters could see the targets or their sights.

## *A Marine Hero Lived Nearby*

### **Frederic Collins Wheeler**

In late May, Bernie McGinley and I were participating in a fund raiser at the Paoli Acme. We met a very pleasant woman who took the time to chat with us and told a story of her grandfather, who, she told us, was a highly decorated Marine Officer who had served in the First World War. Her understanding of his awards were that he had all of the major U.S. and foreign awards available at the time and was the most highly decorated American Marine, not awarded the Medal of Honor.

We listened politely and did some independent research. We found that Captain Wheeler, then a First lieutenant, was a real Marine hero. He was awarded the Navy Cross for valor on June 5, 1918. During that engagement at Belleau Wood, he was wounded twice and refused to leave the battlefield. It was only after sustaining his third wound that he was compelled to leave his post. The French awarded him the Croix de Guerre, With Palm for Valor in action on July 19, 1918. His citation reads: On July 19, 1918, near Vieray, he led his company to an advanced position in spite of serious losses caused by machine guns and artillery of the enemy. Although severely wounded he continued his march under the fire of the enemy to indicate to his men the position to occupy. He refused the service of a runner knowing that this man would be exposed to the danger of certain death.

In addition to his Navy Cross and Croix de Guerre, Captain Wheeler was awarded The Distinguished Service Cross, Purple Heart w/ Oak Leaf Cluster, WW I Victory Medal and the WW I Occupation medal.

After the War to End All Wars, Mr. Wheeler served as Vice President of Fidelity Bank. He was laid to rest at 84 years of age at The Church of the Redeemer, Bryn Mawr, PA.

## The Legend Continues ...

### HAITI Background

In order to understand U. S. involvement in that troubled land and the employment of U. S. Marines to a combat role there, some history of that country is needed to appraise the situation.

Formerly named Saint Domingue, it shares the western third of the island of Hispaniola with the Spanish speaking Dominican Republic. Christopher Columbus discovered the island in 1492, and from the wreck of his flagship, Santa Maria, founded the first Spanish settlement in the New World. France defeated Spain, in war, and took over the country and proceeded to annihilate the native Arawak Indians via massacre, overwork, European epidemics or despair. The colony became the richest French colony and furnished two-thirds of the overseas trade and also supplied half of Europe's consumption of tropical produce. Saint Domingue was also one of the world's greatest markets for the African slave trade. Most slaves died within a few years from hard labor. The slaves, here, were unlike their American counterparts in that they retained their languages, religion, tribal customs and culture values. They developed a French-African vocabulary known as Creole and also a spiritual type of religion called Voodoo. Slavery in French Saint Domingue also bred an element of mixed blood, French-African, White-Black called Mulattoes which created a society relationship that divides the people to this day.

The African slaves revolted to 1791 and defeated the French. Later, they defeated armies sent from Spain, England and France whose intent was to recapture and to rule the island.

On 1 January 1804, Saint Domingue proclaimed their independence and became the world's first Black Republic and also adopted the Arawak Indian name of HAITI.

Those blacks that rebelled against the hardships of the soil were usually illiterate and Public Service positions remained closed to them. Mulattoes, on the other hand, were usually literate and often highly educated, dominated the professions and civil service, controlled the economy and effectively governed the Black Republic. In 1843, revolt signaled the end of Mulattoe Presidencies and for 15 years, black generals ruled.

In 1849, Faustin Soulouque, an illiterate black general, declared himself to be Emperor and created a court of instant nobles and ruled until 1859 after destroying Haiti with corruption, debt, debased currency and a series of military defeats in attempt to capture the Dominican Republic. His legacy resulted in a ruinous class/caste structure, whereas, blacks dominated the powerful army and Mulattoes ran the country, owned and controlled the economy.

**General Meeting Minutes – 3 August 2009**

Commandant: Earle Drake opened the meeting at 1930 and the regular opening ceremonies were conducted. Officers present were Commandant Earle Drake, Sr. Vice Bob Cosgrove, Jr. Vice Jack McLeod, Judge Advocate Dan Luty, Adjutant Jack Kelly, Paymaster Bob Spano, Chaplain Chris Bush, Sergeant-at-Arms Jim Ross, Service Officer Connie McGinley, Director Paul Ferguson, Director Jim Herbst, and Junior Past Commandant Jerry Leon.

Minutes: Joe Mensack made a motion to accept the minutes of the 6 July 2009 general meeting as published in the *Scuttlebutt*. George Boyajian seconded the motion and the motion passed.

New Member: Gerald (Jerry) Mc Guckin was sworn in as a regular member of the Detachment.

Commandant's Report: Commandant Earle Drake reported on a busy month for the month of July for the Detachment. He also reported that seven members had the opportunity to visit the NovaCare Complex and Lincoln Financial Field where the Philadelphia Eagles play. Leo Carlin, a Detachment member and ticket manager for the Philadelphia Eagles, was the guide for this tour. Earle Drake mentioned that the first annual one hundred yard rifle match had been conducted recently.

Officer Reports:

Jr. Vice: Jack McLeod reported on the Help Our Heroes Campaign, with no material progress since the prior general meeting. Only seven members have participated in the campaign so far. Jack McLeod also displayed two new signs that will be used at store events in the Help Us Help Others campaign. In the Help Us Help Others campaign, fourteen weekend events have taken place so far. Donations received year to date have significantly exceeded those collected last year. More than \$43,000.00 has been collected this year, compared to \$23,000.00 for the same time last year.

Paymaster: Bob Spano provided the Paymaster's report as of 31 July 2009. Due to expenses in two budget categories being more than originally anticipated, it was mentioned that increases in the budget for those two categories would be necessary. Bob Spano made a motion to increase the V.A.V.S. line item from \$500.00 to \$2,500.00. George Boyajian seconded the motion, and the motion passed. Bob Spano made a motion to increase the Meeting Expenses line item from \$600.00 to \$1,200.00. Bob Cosgrove seconded the motion, and the motion passed. George Boyajian made a motion to accept the Paymaster's report as received. Dan Luty seconded the motion, and the motion passed.

Sr. Vice: Bob Cosgrove provided details on the upcoming Combined Veterans Alliance picnic, scheduled for 23 August 2009 at Drexel Lodge. A sign-up sheet was

circulated during the meeting to determine the number planning on attending. Bob Cosgrove also provided some details on the annual Marine Corps Ball to be held in November. Major Joe Featherstone, USMC, retired, will be the speaker.

Adjutant: Jack Kelly indicated that the Detachment had received thank you notes from two more of the recent scholarship recipients. Thank you notes were received from Julia Cutting and Amanda Andrews. In addition, letters of thanks were received the Injured Marine Semper Fi Fund and the Philadelphia Stand Down organization. Both organizations had recently received donations from the Detachment. In addition, a thank you note was read received from a family member of a person buried in one of the recent military funerals, and the family's appreciation was extended to the Honor Guard.

Sergeant-at-Arms: Jim Ross read from a recent guideline from Headquarters Marine Corps, in reference to saluting the national colors when in uniform and when not in uniform. Commandant Earle Drake mentioned that our Detachment will follow this ruling.

Service Officer: Connie McGinley mentioned that the Auxiliary may need financial assistance to provide food for an upcoming picnic at the Coatesville Veterans Hospital. Connie McGinley made a motion to provide the Auxiliary with up to \$250.00 for expenses, as needed, for the picnic at Coatesville. Joe Hudson seconded the motion, and the motion passed.

Director Paul Ferguson: Paul Ferguson mentioned that he had been in contact with the USO concerning returning troops from the war zone. There is a group from the 56<sup>th</sup> Stryker Brigade that is returning from Iraq on 11 September, and those interested can meet the troops at Fort Dix, NJ. Those members who are interested could assist in serving a hot meal to these returning troops. A sign-up sheet was circulated to determine which members would be interested meeting these returning troops.

Committee Reports:

Adopt-a-Highway: John Burfete indicated that the date for the next Adopt-a-Highway event has been changed from 16 August to 30 August 2009.

Flag Collection: Barry Reese reported that the collection of used or torn flags is ongoing. Used flags are being collected, and it will be necessary to schedule a date in the future for the burning of used flags.

The U.S. also played a large part in ruining the economy of that country. Haiti found itself barred from world commerce just by having the audacity in freeing her own slaves and defying every notion of black inferiority by militarily defeating three European powers. This was an unpardonable sin! The U.S. received no Mulatto Consuls or Black Ambassadors from Haiti because the peace of eleven slave states might be in jeopardy because of Haiti's successful insurrection. There were also international alliances with France, England and the U.S. diplomatic treaties leaving Haiti the perpetual loser.

Haiti was in continuous turmoil. It was hopelessly in debt, for foreign governments lent money indiscriminately, enslaving Haiti economically, and then, demanding payment which could only be paid by borrowing again. American railroads claimed exorbitant sums for providing Haiti with a poorly built and operating railroad system.

The magnet that drew European powers towards small, impoverished Haiti was not its debts but the country's strategic position in the Caribbean. President Theodore Roosevelt declared in 1904 that only the U.S. alone, via the Monroe Doctrine, had the right to police the little countries of the western hemisphere, to protect property, maintain order and make sure that they paid their debts. By 1915, we had intervened in Columbia to create Panama for a future canal (1903), Honduras (1907), Nicaragua (1910-1912) and Mexico (1914). They would also take over the Dominican Republic from 1916 thru 1924.

In the 72 year period before the Marines came ashore in July 1915, Haiti had 102 civil wars, revolutions, insurrections, revolts and coups. Of 22 Presidents, just one served a complete term. Only four died of natural causes. Thirteen were ousted by coups. The others suffered violent deaths via civil unrest.

This temporary incursion by the U. S. Marines would last until August 1924.
